



12.1 LOVE MY PLACE 2023/24 RECOMMENDATIONS FOR

1. PURPOSE

1.1 To present the recommended Love My Place grant recipients for 2023/24 for Council approval.

2. EXECUTIVE SUMMARY

2.1 The Program seeks to activate public spaces within the City of Port Phillip through unique events, experiential public art, and experimental installations and ideas.

2.2 This report presents Council with a list of proposed grants recommended by the Love My Place Evaluation Panel. Funded projects will take place between November 2023 and June 2024.

2.3 A total of \$77,500 in grants were recommended to fund 6 projects for this round.

2.4 17 eligible applications were received, requesting a combined funding of \$236,701 for projects valued at a total of \$378,390.

2.5 The 6 recommended projects have a total value of \$110,615. Representing an average of \$1.42 for every \$1 invested by Council.

2.6 Projects were selected based on a 12-point criteria that includes identification of a community need, project uniqueness, applicant's resources and experience, equitability and inclusivity, and value for money.

3. RECOMMENDATION

That Council:

3.1 Endorses the recommended successful applicants as proposed by the Love My Place Evaluation Panel as outlined in Confidential Attachment 1.

3.2 Releases details on the successful recipients of the Love My Place Grants Program from confidence once all applications have been advised of the outcome of their application and those successful have confirmed their ability to proceed with their application.

3.3 Thank all applicants who participated in the 2023/24 round for Love My Place Grants Program.

4. KEY POINTS/ISSUES

4.1 With the LMP program, the City of Port Phillip (CoPP) encourages our community to trial new ideas through creative activities within the public realm.

4.2 LMP was created to support local businesses through the activation of public spaces within the City of Port Phillip.



4.3 Selection criteria includes:

- How the grant application (the Project) meets the objectives of the Program, including activation of public space and its support of local community and businesses.
- How the Project addresses Council's strategic directions.
- Whether the project has resulted from an identified community need and how effectively the project addresses this need.
- The expected benefits delivered through the project to the City of Port Phillip community and businesses e.g., increasing the time spent in an area, benefiting local business precincts or neighbourhoods or encouraging visitation from locals and visitors.
- A creative approach has been considered to deliver a unique/one-of-a-kind experience.
- The environmental sustainability of the project. i.e., measures taken during an event to manage and reduce waste, end-of-life cycle of the project, source and travel distance of supplies, as well as other general considerations to mitigate the environmental impact caused by the initiative.
- That the applicant has the necessary resources and experience to manage and deliver the project.
- That the project has been fully planned to include budgets, deliverables, timeframes, risk management, and contingencies.
- How well the budget allocation reflects the most value for money (economic, social, and environmental sustainability).
- That a clear evaluation methodology has been put in place to assess the project's success and participant/audience engagement.
- How easily can the project be altered in response to Panel and community feedback.
- That the project promotes equitability considering universal design, accessibility, and inclusivity.

4.4 The process for application is as follows:

- A call for applications was advertised through, Council's website, Businesses newsletter, Trader Organisation's media channels, ArtsHub, as well as a CoPP social media campaign.
- Applications were made using the online grants management system, Smartygrants.
- Applications closed on 10 September 2023.
- Applications were assessed by the Love My Place Evaluation Panel according to the 12-point criteria and the Panel met in person on 4 October 2023 where combined scores and funding were discussed.
- The Evaluation Panel voted to fund 6 projects.

4.5 The Panel considered that the unsuccessful applications lacked on one or more of the 12-point assessment criteria or aligned better to a different Council funding program.



5. CONSULTATION AND STAKEHOLDERS

- 5.1 The Love My Place Evaluation Panel is comprised of one Councillor, and four Council Officers with expertise in the areas of Arts, Events and Activation.
- 5.2 The projects invited a broad level of engagement and opportunities for community reach through different media channels.

6. LEGAL AND RISK IMPLICATIONS

- 6.1 There are no known risks to Council in adopting this recommendation.

7. FINANCIAL IMPACT

- 7.1 The total amount of funding recommended for the 6 projects is \$77,500 out of the \$100,000 allocated in the 2023/24 budget.
- 7.2 Creative practice is recognised as making a valuable contribution to the City of Port Phillip's economy. As a sector, creative and cultural practice and industries are the second largest employer in the City of Port Phillip.
- 7.3 Public space activation such as community events and art installations engage with local business community as supporters but also draw community and broader audiences to business precincts.

8. ENVIRONMENTAL IMPACT

- 8.1 Cultural and community organisations will be made aware of Council commitment to environmental sustainability through the Council Plan.
- 8.2 Recommended projects selection process included their demonstrated ability to reduce and offset their environmental impact.

9. COMMUNITY IMPACT

- 9.1 The Love My Place Grants Program delivers community lead projects that enliven our Local Activity Centres.
- 9.2 Community engagement and cultural participation are contributing factors to community health and wellbeing.
- 9.3 Funded projects offer free or low-cost access to diverse cultural activities across the municipality.
- 9.4 Community members of all abilities and diverse backgrounds are encouraged to participate in funded programs.
- 9.5 The projects directly and indirectly benefit our local businesses and promote utilisation of public space.

10. ALIGNMENT TO COUNCIL PLAN AND COUNCIL POLICY

- 10.1 Funding under Love My Place Grants delivers on the Council Plan 2021-31:
 - Vibrant Port Phillip – A City that has a flourishing economy, where our community and local businesses thrive, and we maintain and enhance our reputation as one of Melbourne's cultural and creative hubs.
 - Liveable Port Phillip – A City that is a great place to live, where our community has access to high quality public spaces, development and growth are well-managed, and it is safer and easy to connect and travel within.



11. IMPLEMENTATION STRATEGY

11.1 TIMELINE

11.1.1 Successful projects will be listed on Council’s website and promoted through the community events listing.

11.1.2 The successful applicants will receive their funding by end November 2023.

11.1.3 Funded projects will be delivered between November 2023 and June 2024.

11.2 COMMUNICATION

11.2.1 Applicants will be advised of the outcome of their application soon after Council decision.

11.2.2 Details of funded projects will be available on the Council website.

11.2.3 Unsuccessful applicants are notified in writing and are invited to receive feedback from Council Officers.
